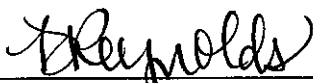

ORDINANCE NO. 2020-3

**AN ORDINANCE TO APPROVE A WATER AGREEMENT
WITH THE CITY OF DECATUR**

BE IT ORDAINED BY THE MAYOR AND BOARD OF TRUSTEES OF THE VILLAGE OF MT. ZION, MACON COUNTY, ILLINOIS AS FOLLOWS:

WHEREAS, the Board of Trustees of the Village of Mt. Zion, Illinois, is of the opinion that it is in the best interest of the Village to enter an agreement with the City of Decatur to secure a supply of treated water from the water works system of the City for the water storage and distribution system of the Village;

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE VILLAGE OF MT. ZION, MACON COUNTY, ILLINOIS:

Section 1. The Agreement between the City of Decatur and Village of Mt. Zion requiring the City to furnish treated and potable water to the Village is hereby approved.

Section 2. The Board of Trustees hereby authorizes the Mayor to execute the Agreement on behalf of the Village of Mt. Zion
