**ORDINANCE 2021-28**

**AN ORDINANCE AMENDING  
THE BUDGET FOR FISCAL YEAR 2021**

**WHEREAS**, State Budget Law provides that a budget may be revised if revenue is available during the fiscal year (Chapter 65-5/8-2-9.6), and;

**WHEREAS**, the budget for the Audit Fund will spend more funds than was appropriated by Ordinance 2020-23, and;

**WHEREAS**, the corporate authorities of the Village of Mt. Zion desire to increase the appropriation of the Audit Fund;

**NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MT. ZION, MACON COUNTY, ILLINOIS, AS FOLLOWS:**

**Section 1:** That total expenditures appropriated for the Audit Fund will be increased from \$22,190.00 to \$28,064.72 for Fiscal Year 2021.

**Section 2:** Ordinance No. 2020-23 is hereby amended.

**Section 3:** This Ordinance shall be in full force and effect from and after its passage, approval and publication as required by law.


