## **ORDINANCE NO. 2022-3**

## ORDINANCE AMENDING CHAPTER 71 – TRAFFIC SCHEDULES IN THE CODE OF ORDINANCES FOR THE VILLAGE OF MT. ZION, ILLINOIS

**WHEREAS,** the Village of Mt. Zion, Illinois, has the lawful authority under the provisions of Illinois Compiled Statutes, 625 ILCS 5/11-208, to enact various traffic regulations within the Village, and

**WHEREAS**, the Village of Mt. Zion, Illinois, has heretofore adopted Ordinances establishing and regulating speed limits on Village streets.

NOW THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MT. ZION, MACON COUNTY, ILLINOIS, AS FOLLOWS:

**SECTION 1:** That Schedule III – Speed Regulations shall be amended by adding the following:

Ashland Avenue – 20 mph Ashland Court – 20 mph Alexander Drive – 20 mph Alexander Court – 20 mph

**SECTION 2:** That staff is hereby directed to cause the appropriate traffic signs giving notice of such speed limits be erected as specified in Section 1 of this Ordinance. The Speed Regulation, as designated by this Ordinance, shall become effective when such signs are so erected.

**SECTION 3:** This Ordinance shall be in effect 10 days after its passage, approval and publication. The Village Clerk is hereby authorized and directed to cause this Ordinance to be published in pamphlet form.
