ORDINANCE NO. 2024-4

ORDINANCE TO INSTALL A YIELD SIGN AT THE INTERSECTION OF ASHLAND AVENUE AND ALEXANDER DRIVE, MT. ZION, MACON COUNTY, ILLINOIS

BE IT ORDAINED BY THE MAYOR AND BOARD OF TRUSTEES OF THE VILLAGE OF MT. ZION, MACON COUNTY, ILLINOIS, AS FOLLOWS:

WHEREAS, the Board of Trustees of the Village of Mt. Zion, Illinois, has the authority to regulate the use of the streets within the Village pursuant to 65 ILCS 5/11-80-2;

WHEREAS, the Board of Trustees of the Village of Mt. Zion, Illinois has determined that the installation of a "Yield" sign at the southeast corner of the intersection of Ashland Avenue and Alexander Drive within the Village is necessary and advantageous and supports the public health, welfare, safety, and morals of the public;

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE VILLAGE OF MT. ZION, MACON COUNTY, ILLINOIS:

Section 1. Recitals. The preliminary paragraphs set forth above are incorporated herein as part of this Ordinance.

Section 2. <u>Installation of Yield Sign.</u> The Village shall install a "Yield" sign at the southeast corner of the intersection of Ashland Avenue and Alexander Drive as soon as possible following the passage of this Ordinance.

Section 3. Effective Date. This Ordnance shall be in full force and effect after its passage and approval according to law.

Section 4. <u>Severability.</u> In the event that any section, clause, provision, or part of this Ordinance shall be found and determined to be invalid by a court of competent jurisdiction, all valid parts that are severable from the invalid parts shall remain in full force and effect.
