AN ORDINANCE AMENDING
THE BUDGET FOR FISCAL YEAR 2017

WHEREAS, State Budget Law provides that a budget may be revised if revenue is available during the fiscal year (Chapter 65-5/8-2-9.6), and;

WHEREAS, the Village of Mt. Zion desires to increase the budget for the General Fund – Convention Center in order to purchase a dishwasher for the Mt. Zion Convention Center, and;

WHEREAS, the Budget for Fiscal Year 2017 for the General Fund – Convention Center included the leasing of a dishwasher and not the purchase of a dishwasher, and;

WHEREAS, the corporate authorities of the Village of Mt. Zion desire to increase the appropriation of the General Fund – Convention Center as it is in the best interest of the Village of Mt. Zion to purchase a dishwasher rather than lease a dishwasher;

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MT. ZION, MACON COUNTY, ILLINOIS, AS FOLLOWS:

Section 1: That total expenditures appropriated for the General Fund – Convention Center will be increased from \$321,800.00 to \$329,800.00 for Fiscal Year 2017.

Section 2: Ordinance No. 2016-10 is hereby amended.

Section 3: This Ordinance shall be in full force and effect from and after its passage, approval and publication as required by law.
