ORDINANCE NO. 2018- 3

ORDINANCE AMENDING CHAPTER 132 - ALARM SYSTEMS
IN THE CODE OF ORDINANCES FOR THE VILLAGE OF MT. ZION, ILLINOIS

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE
VILLAGE OF MT. ZION, MACON COUNTY, ILLINOIS, AS FOLLOWS:

Chapter 132, ALARM SYSTEMS, is hereby amended:

A. Amending Section 132.04 to read as follows:

S 132.04 Response Charge.

(A) A response charge in the amount of \$35.00 may be imposed for each
response by Village of Mt. Zion Police Department to a false alarm.

(B) Should any alarm user fail to reasonably and promptly pay a response charge
after being billed for the same, all alarm systems of that alarm user may be
disconnected from the alarm service panel; and in addition thereto, said charge
may be recovered by appropriate court action.
