ORDINANCE 2017- 3

AN ORDINANCE AMENDING
THE BUDGET FOR FISCAL YEAR 2016

WHEREAS, State Budget Law provides that a budget may be revised if revenue is available during the fiscal year (Chapter 65-5/8-2-9.6), and;

WHEREAS, the Village of Mt. Zion desires to increase the budget for the 2013 G.O. Bond & Interest Repayment Fund in order to cover expenses incurred during the fiscal year, and;

WHEREAS, the budget for the 2013 G.O. Bond & Interest Repayment Fund will spend more funds than was appropriated by Ordinance 2015-16-32, and;

WHEREAS, the corporate authorities of the Village of Mt. Zion desire to increase the appropriation of the 2013 G.O. Bond & Interest Repayment Fund;

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MT. ZION, MACON COUNTY, ILLINOIS, AS FOLLOWS:

Section 1: That total expenditures appropriated for the 2013 G.O. Bond & Interest Repayment Fund will be increased from \$66,463.00 to \$66,963.00 for Fiscal Year 2016.

Section 2: Ordinance No. 2015-2016-32 is hereby amended.

Section 3: This Ordinance shall be in full force and effect from and after its passage, approval and publication as required by law.
