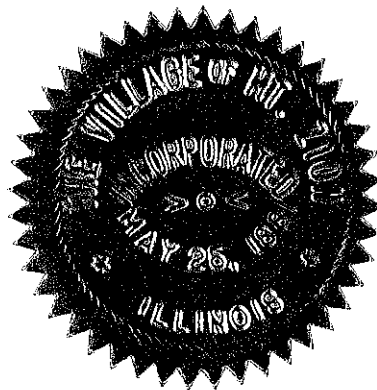

ORDINANCE NO. 2018-13

AN ORDINANCE APPROVING THE SPECIAL USE PERMIT REQUEST TO ALLOW A COMMUNITY INTEGRATED LIVING ARRANGEMENT (CILA) FOR FOUR DEVELOPMENTALLY DISABLED ADULTS FOR CERTAIN PROPERTY LOCATED AT 321 ROLLING GREEN DRIVE WITHIN THE VILLAGE OF MT. ZION, ILLINOIS

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MT. ZION, MACON COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: On the 10th day of July, 2018 the Mt. Zion Planning Commission and Zoning Board of Appeals, upon due notice held a public hearing on the petition for a Special Use Permit to allow a CILA at the property legally described as follows:

L 0017 B 00 Rolling Green Estates 100X99, Macon County, Illinois.

SECTION 2: The Mt. Zion Planning Commission and Zoning Board of Appeals has recommended the granting of the Special Use Permit as requested.

SECTION 3: Following a full and complete review of the evidence presented to the Mt. Zion Planning Commission and Zoning Board of Appeals and after careful consideration of the law regarding a CILA, the Mt. Zion Village Board of Trustees has approved the Special Use Permit for 321 Rolling Green Drive. The Ordinance granting this Special Use Permit allows no more than four disabled adults to reside at this property at one time.

SECTION 4: The Special Use Permit granted hereby is made subject to all other applicable requirements of the Zoning Code of Mt. Zion, Illinois and is non-transferable.

SECTION 5: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.


