ORDINANCE 2018- 14

AN ORDINANCE APPROVING AND AUTHORIZING ENTERING INTO AND EXECUTING A CABLE TELEVISION FRANCHISE AGREEMENT BETWEEN THE VILLAGE OF MT. ZION AND COMCAST OF ILLINOIS/INDIANA/OHIO, LLC.

WHEREAS, the Village of Mt. Zion ("Village") is an Illinois non-home rule unit of local government pursuant to Section 7 of Article VII of the Illinois Constitution of 1970 and the Statutes of the State of Illinois; and

WHEREAS, the Village desires to renew its cable franchise agreement with Comcast.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MT. ZION, MACON COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: That certain Franchise Agreement by and between the Village of Mt. Zion and Comcast of Illinois/Indiana/Ohio, LLC, a copy of which is attached hereto, is hereby approved.

<u>SECTION 2:</u> The President is authorized and directed to execute said Franchise Agreement on behalf of the Village, and the proper officers of the Village are directed to carry out the Franchise Agreement by its terms.

SECTION3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
