## ORDINANCE NO. 2019-11

## AN ORDINANCE AMENDING THE VILLAGE OF MT. ZION CODE OF ORDINANCES TITLE XI: BUSINESS REGULATIONS CHAPTER 110 ALCOHOLIC LIQUOR CONTROL **SECTION 110.10 LICENSE FEES**

WHEREAS. Section 7 of Article VII of the 1970 Constitution of the State of Illinois provides that a municipality that is not a home rule unit shall only have the powers granted to them by law and as such the Village of Mt. Zion, Macon County, Illinois being a non-home rule unit pursuant to the provisions of said Section 7 of Article VII, and may exercise only the powers expressly granted by law; and

WHEREAS, the Illinois General Assembly granted non-home rule municipalities broad authority to "pass all ordinances and make all rules and regulations proper or necessary, to carry into effect the powers granted to municipalities." 65 ILCS 5/1-2-1; and

WHEREAS, Section 4-1 of the Liquor Control Act of 1934 (235 ILCS 5/4-1) gives the Village Board the power by general ordinance or resolution to establish regulations and restrictions upon the issuance of and operations under local liquor licenses; and

WHEREAS, the Village Board of Trustees desires to amend its Code of Ordinances to amend Section 110.10 License Fees.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MT. ZION, MACON COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: Chapter 110, of the Village of Mt. Zion, Code of Ordinances, Alcoholic Liquor Control, is hereby amended to read as follows:

(A) The fee for each class of license shall be \$1,500 per year except for a Class G License which shall have a fee of \$1,250.00 per year and a Class H License which shall have a fee of \$750.00 per year. License fees for each alcoholic liquor license shall be payable on or before July 1 of each year.

SECTION 2: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
