

ORDINANCE 2019-17

**AN ORDINANCE FOR THE LEVY AND COLLECTION
OF DIRECT ANNUAL TAX TO PAY ANNUAL INSTALLMENTS
BEGINNING JANUARY 1, 2020 OF THE VILLAGE OF MT. ZION,
COUNTY OF MACON, STATE OF ILLINOIS**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE
VILLAGE OF MT. ZION, COUNTY OF MACON, STATE OF ILLINOIS, AS FOLLOWS:**

SECTION 1: That for the purpose of providing money for the annual lease payment of equipment of the Village of Mt. Zion, a tax be levied in the amount of \$87,880.00, pursuant to IL Compiled Statutes, Ch 65, Sec. 5/11-76.1-2.

SECTION 2: That the said sum is to be collected by separate tax levy for payment based on the following schedule and attached lease:

SECTION 3: That the Village of Mt. Zion shall be authorized to levy an additional tax of .01400 of the value of all of the taxable property within the limits of the Village, as equalized or assessed by the Department of Revenue, for the purpose of the Village of Mt. Zion Equipment Lease Fund.

SECTION 4: That the said sum as ascertained aforesaid be and the same is levied and assessed on all properties subject to taxation with the Village of Mt. Zion according to the value of said property and as the same is assessed and equalized for the state and county purposes for said length of lease.

SECTION 5: That it is hereby certified to the County Clerk of Macon County, Illinois, the sum aforesaid, constituting the total amount of the Lease/Purchase Fund Tax, which said total amount the said Village of Mt. Zion required to be raised by taxation for said length of the attached Lease of said Village, and the Village Clerk, if said Village, is hereby ordered and directed to file with County Clerk of said County, on or before the time required by law, a certified copy of this Ordinance.

SECTION 6: That within 15 days from the adoption of this Ordinance, the Village Clerk, of the Village of Mt. Zion is directed to publish this Ordinance two times in a newspaper published within the District.

SECTION 7: The Publication Notice shall include Notice of the specific number of voters required to sign a Petition to request the question of adoption of this Ordinance

be submitted to the electors of the District; the time in which the Petition must be filed and the date of the perspective referendum.

SECTION 8: The Village Clerk of the Village of Mt. Zion shall provide a Petition to any individual requesting one, setting forth the above referenced information.

SECTION 9: If no Petition is filed with the Village of Mt. Zion within 30 days after the second publication of this Ordinance of the Village of Mt. Zion, then the Village of Mt. Zion shall be authorized to levy the tax. However, if within the 30 day period, a Petition is filed at the Village of Mt. Zion Corporate Offices, 1400 Mount Zion Parkway, Mt. Zion, IL 62549, signed by electors of the Village of Mt. Zion, equal in numbers to 10% of the total number of registered voters that reside within the Village limits, requesting that the question of the levy of the Equipment Lease Fund be submitted to the electors of the Village, the question shall be certified to the proper election official who shall submit the question to an election in accordance with the general election law.

SECTION 10: The Petition asking that this question be submitted to voters who reside within the Village of Mt. Zion, shall contain not less than 415 signatures of registered voters who reside within the Village limits. In the event a Petition in the proper form is filed with the Board of Trustees of the Village of Mt. Zion, asking that this question be submitted to the voters of the Village, the date of such election shall be March 17, 2020.

SECTION 11: This Ordinance shall be in full force and effect from and after its passage and publication as required by law.
