## **ORDINANCE 2020-11**

## AN ORDINANCE AMENDING THE BUDGET FOR FISCAL YEAR 2020

**WHEREAS**, State Budget Law provides that a budget may be revised if revenue is available during the fiscal year (Chapter 65-5/8-2-9.6), and

**WHEREAS**, the Village of Mt. Zion desires to engineer a relief line(s) to increase the capacity of its sewer main system to alleviate back-ups for residences east of State Highway 121, and

**WHEREAS**, the budget for the Sewer Fund will spend more funds than were appropriated by Ordinance 2019-25, and

**WHEREAS**, the corporate authorities of the Village of Mt. Zion desire to increase the appropriation of the Sewer Fund.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MT. ZION, MACON COUNTY, ILLINOIS, AS FOLLOWS:

**Section 1**: That total expenditures appropriated for the Sewer Fund be increased from \$508,350 to \$567,350 for Fiscal Year 2020.

Section 2: Ordinance No. 2019-25 is hereby amended.

**Section 3**: This Ordinance shall be in full force and effect from and after its passage, approval and publication as required by law.
