AN ORDINANCE AMENDING THE BUDGET FOR FISCAL YEAR 2020

WHEREAS, State Budget Law provides that a budget may be revised if revenue is available during the fiscal year (Chapter 65-5/8-2-9.6), and

WHEREAS, the budget for the Liability Insurance Fund will spend more funds than were appropriated by Ordinance 2019-25, and

WHEREAS, the corporate authorities of the Village of Mt. Zion desire to increase the appropriation of the Liability Insurance Fund.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MT. ZION, MACON COUNTY, ILLINOIS, AS FOLLOWS:

Section 1: That total expenditures appropriated for the Liability Insurance Fund be increased from \$77,000 to \$80,480 for Fiscal Year 2020.
