

ORDINANCE NO. 2022-8

**ORDINANCE AMENDING CHAPTER 71 – TRAFFIC SCHEDULES
IN THE CODE OF ORDINANCES FOR THE VILLAGE OF MT. ZION, ILLINOIS**

WHEREAS, the Village of Mt. Zion, Illinois, has the lawful authority under the provisions of Illinois Compiled Statutes, 625 ILCS 5/11-208, to enact various traffic regulations within the Village, and

WHEREAS, the Village of Mt. Zion, Illinois, has heretofore adopted Ordinances establishing and regulating parking on Village streets.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MT. ZION, MACON COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: That Schedule V – Parking Code shall be amended by adding the following:

<u>Street</u>	<u>Side of Street</u>	<u>Portion or Section</u>	<u>Prohibition</u>
Finley Ave.	West/North side	From Dee Lee Lane to the southwest corner of 1085 Finley Ave.	No Parking

SECTION 2: That staff is hereby directed to cause the appropriate traffic signs giving notice of such parking prohibition to be erected as specified in Section 1 of this Ordinance. No Parking, as designated by this Ordinance, shall become effective when such signs are so erected.

SECTION 3: This Ordinance shall be in effect 10 days after its passage, approval and publication. The Village Clerk is hereby authorized and directed to cause this Ordinance to be published in pamphlet form.




