**ORDINANCE 2023-7**

**AN ORDINANCE AMENDING CHAPTER 50-WATER  
IN THE CODE OF ORDINANCES FOR THE VILLAGE OF MT. ZION, ILLINOIS**

**WHEREAS**, the Village of Mt. Zion, Illinois, is an Illinois Municipality organized and operating pursuant to the Illinois Municipal Code (65 ILCS 5/1-1-1, *et.seq.*); and

**WHEREAS**, pursuant to Section 11-139-8 of the Illinois Municipal Code, the corporate authorities of the Village of Mt. Zion may enact and enforce all needful rules and regulations for the acquisition, construction, extension, improvement, management, and maintenance of the combined waterworks and sewerage system and may establish and charge inhabitants reasonable compensation for the use and service of said system (65 ILCS 5/11/139-8); and

**WHEREAS**, the President and Board of Trustees have reviewed the recommendation of Village staff regarding proposed changes to the water service rates; and

**WHEREAS**, charges shall be made to the consumers of water services that are sufficient to pay the costs of maintenance, operations, and depreciation of the water system and to pay the principal and interest on any debt that may be issued for the construction, installation, repair, and improvement of the water system; and

**WHEREAS**, the President and Board of Trustees deem it to be in the best interest of the Village to amend Chapter 50 - Water, of the Village of Mt. Zion Municipal Code, to amend Section, 50.15 Water Service Rates; Penalty; Discounts for water consumed to ensure sufficient funding of the operation of the water system;

**NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MT. ZION, MACON COUNTY, ILLINOIS, AS FOLLOWS:**  
**SECTION 1:** Chapter 50 Water is hereby amended.

**Section 50.15 Water Service Rates; Penalty; Discounts**

(A) Each water service shall pay therefore on the basis of gallons of water used per month, beginning June 1, 2023, according to the following scale of rates:

First 2000 gallons or part thereof \$35.36/month (minimum)

Next 2000 gallons or part thereof \$16.10/1000 gallons

Next 2000 gallons or part thereof \$14.13/1000 gallons

Next 4000 gallons or part thereof \$12.60/1000 gallons

In excess of 10,000 gallons or part thereof \$10.85/1000 gallons

Second Meters - \$10.50/1,000 gallons

Beginning June 1, 2024, an additional 2.5% annual increase will be added to the previous year's scale of rates.

Water Users at property located outside of corporate limits of the Village of Mt. Zion:

First 2000 gallons or part thereof \$53.04/month (minimum)

Next 2000 gallons or part thereof \$24.15/1000 gallons

Next 2000 gallons or part thereof \$21.20/1000 gallons

Next 4000 gallons or part thereof \$18.90/1000 gallons


In excess of 10,000 gallons or part thereof \$16.28/1000 gallons

Second Meters - \$16.00/1,000 gallons

Beginning June 1, 2024, an additional 2.5% annual increase will be added to the previous year's scale of rates.

**SECTION 2:** This ordinance shall be in full force and effect from and after its passage, approval, and publication as required by law.
